






Elements of effective road safety management

To achieve better performance in road safety we need an effective road safety management

There is a need to address systematically the main risk factors and adopting proven measures more widely with appropriate resource by a combination of:





Sharing responsibility

Work Related Road Safety Plans WRSP

Promoting and implementing a Road Safety Culture inside organizations focused on Risk Management



WRSP Approach





1- Risk diagnosis

Through a quantitative and qualitative evaluation this step should allow to define:

- The main characteristics of accidents and determine the most common type of accident in the company;
- ➤ The risk behaviors of the company's drivers;
- ➤ Risk factors related to the planning and organization of the journey, the characteristics and condition of the vehicles, behaviors and skills of drivers and the road environment;
- ➤ The direct and indirect costs supported by the company;
- ➤ Drivers over represented in statistics



1- Risk diagnosis

Deliverable - Report with following contents:

- ➤ Description of the actual situation and identification of problems
- ➤ To define targets and Kpi's
- ➤Identifying and prioritizing needs and actions to be implemented in order to reduce the frequency and severity of accidents;
- ➤ To define the vision and the structure of a road safety policy of the company;



2- Organization Actions

In straight collaboration with the road safety management structure the preventive measures are defined in order to:

- Implement and develop a road safety culture
- ➤ Define hiring procedures, integration and training of professional drivers and other vehicle users;
- ➤ Define and implement a strategy of information and motivation/awareness of drivers;
- Planning and organizing journeys



2- Organization Actions

- ➤ Build a database and information collection model to systematic analysis the road accidents.
- ➤ Create KPI's;
- ➤ Design the process of monitoring and evaluate the results;
- ➤ Define prevention policies against risk factors (vehicles; route management; speed, alcohol, distraction, fatigue programs)

Deliverable: Road Safety Organization Action plan



3- Behavior Actions

Based on available data and information collected about drivers some actions could be implemented in order to change opinions, attitudes and behaviors:

- Start a reflection on driving habits;
- Identify the risks involved on journeys.
- To know the opinion, attitudes and behaviors of drivers and motivate the necessary changes;
- Promote a safe behavior



3- Behavior Actions

Deliverables:

- Theoretical training Aimed at changing behavior in accordance with the goals settled by the organization management
- Practical training Risk assessment; hazard perception, defensive driving, eco driving, etc.
- Group dynamics (behavior experts psychologist)
- Awareness campaigns/events



4- Monitoring and evaluating

Monitoring and analyzing data collected and KPI's to:

- > Evaluate the implemented measures
- > Evaluate the impact of training and other measures
- ➤ Define characteristics and circumstances of the accidents;
- Check the implementation of security procedures.




4- Monitoring and follow up of the corrective measures

- > Analyze the evolution and characteristics of accidents;
- > Evaluate internal communication;
- > Evaluate the progress on opinions, attitudes and behaviors
- > Implement corrective measures

Deliverable: Evaluation and progress report / Corrective measures
